SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures:

The symptoms resulting from intoxication can appear after exposure, therefore, in case of doubt, seek medical attention for direct exposure to the chemical product or persistent discomfort, showing the SDS of this product.

By inhalation:

Remove the person affected from the area of exposure, provide with fresh air and keep at rest. In all cases, after cleaning, a doctor should be consulted as quickly as possible with the SDS for the product.

SECTION 5: FIREFIGHTING MEASURES (continued)

As a result of combustion or thermal decomposition reactive sub-products are created that can become highly toxic and, consequently, can present a serious health risk.

Isolate leaks provided that there is no additional risk for the people performing this task. Evacuate the area and keep out those without protection.
